Dear President Trump and Vice President Pence,

As 2020 draws to a close, the undersigned organizations, representing millions of Americans, wish to thank you for all you have done over the last four years to protect the dignity of human life.

President Trump, as a candidate, on January 23, 2016, you stated, “Let me be clear – I am pro-life.” As President, you have lived up to that statement in standing up for women and the unborn. Your Presidency has been unprecedented in American history for its bold leadership in the protection of the unborn. As you stated this past year in January, when you became the first President of the United States to ever personally attend the March for Life:
